

# "SHOO SHOO BABY" AN 8th AIR FORCE CENOTAPH

THE DISMANTLED SKELETAL REMAINS OF THE 401ST SQ, 91st BG(H)'s "Shoo Shoo Baby" arrived at the Dover AFB, DE ten years ago. The 512th Military Aircraft Wing stationed there had offered to restore her while she sat in disrepair at the Air Force Museum at Wright Patterson AFB, OH.

On Sept 10, 1988, before 5,000 people, "Roll-Out Ceremonies" at

the Dover AF Base revealed a miraculous restoration.

"It's almost like it came out of the factory!" said Dr. William Hospers, a retired Army Colonel and owner of "Chuckie," another restored and operational B17-G based in Fort Worth, TX. Hospers, designated to be "Shoo Shoo Baby's" Commander on her final flight to the AF Museum, wasn't the only one who expressed amazement over the restoration work done by MSGT Raymond McCloskey, TSGT Dan Vasey, MSGT Tom Corbeil and MSGT Vic Rosica and many, many others.

All who witnessed "Shoo Shoo Baby" roll-out from her hangar and then stand, majestically poised, like a true Queen awaiting deserved adulation, responded emotionally. The long, hushed pause when the plane first appeared followed by enthusiastic applause indicated that.

"It (the 'Roll-Out Ceremony") was a 'tear-jerker," one of the throng at the historic event wrote the R/I. He did not exaggerate.

# ARBITRATION TO CONCLUDE CONVENTION BUSINESS

THE BUSINESS OF THE AUG. 31-SEPT. 4, 1988 91st BGMA Chicago Convention, attended by some 300 members and guests, is not complete. Unforeseen difficulty involving the Absentee Ballots has clouded some of the election results.

The Convention Business, presided over by outgoing Pres. Paul Chryst, certainly pleased the overwhelming majority of those attending. Anticipated afternoon activities arranged by Chicago Convention Chairman Sam Cipolla were not infringed upon.

The applause concluding the Business Meeting was an award for all

the outgoing officers and a welcome for the newly elected.


Col. Tony Montalvo (Ret.), President-Elect, and the other 91st
BGMA elected officials will take office Jan. 1, 1989. This is because the Convention voted henceforth time be provided for outgoing officials to transfer records to the newly elected officials before saddling them with responsibility.


Col. Montalvo (401st/324th), of California, in a statement to BGMA members said, "I invite all of you to join us in making the the 91st BGMA the best in the land...similarly to the manner in which we were the best in fighting our enemies. I, and all those elected and those who have already accepted appointed posts, thank you for this opportunity to serve you."

Among the exciting projects Col. Montalvo plans for his term is the publication of a histoirical record of 91st BG(H) activities through Aug. 1945. Former BGMA 1st VP Hiliary "Bud" Evers has been designated the Action Officer of this endeavor.

The writer was Col Paul G. McDuffee, "Shoo Shoo Baby's" original pilot.

Some 20 years earlier in July 1968 Steve Birdsall roused him from sleep in his Tampa, FL home with a long distance call from Sydney, Austrailia. Birdsall, whose hobby was locating surviving B17's, told McDuffee, over the imperfect connection, "I've found your airplane."

McDuffee's reply was a shouted, "You what?"

From that moment on McDuffee's involvement in the return and restoration of the 401st plane he selected on Mar. 5, 1944 for his "own" because of its inherent stability has become legend. Included in the legend is his opinions regarding affairs related to her since Birdsall's discovery were rarely couched in dulcet tones.

Now confined to a wheel chair, McDuffee was probably the only one who remained seated when "Shoo Shoo Baby" emerged. While others stood and applauded her and the ten year dedicated diligence of the 512th MAW, the highest tribute to her and the 512th was witnessed by only a few.

McDuffee had removed his 512th MAW cap and lowered his head soon after his plane began its roll-out. When his hands rose to shield his face the extent of the emotion welling up within him was apparent.

His response, it has since been determined, was not entirely unique.

Many others struggled with emotion.

It is certain the 512th MAW and all others who contributed to "Shoo Shoo Baby's" restoration will cherish the memory of the many momentarily overcome when she emerged from her Dover AFB hangar in 1988 - as proud and beautiful as she was in 1944 when then 2Lt. Paul G. McDuffee claimed her.


In reply to a request from the R/I for a statement on the ceremonies,

McDuffee wrote:

"It was indeed an emotional affair...particularly for the crew members who were in attendance. I have had reports from all of them and there was not one who did not shed tears as that Fortress was rolled out of that hangar. For myself, it was especially emotional..."

"This aircraft and the crew members who flew it during the Air War in Europe is reflective of no one individual nor one individual crew. Contrariwise it represents a lasting tribute to all those gallant young men who gave their lives in defense of principle and morality. Enshrined in the Air Force Museum, this great aircraft will be a premanent cenotant to all 8th AF WWIII personnel."

Ten other "Shoo Shoo Baby" Crew members, along with McDuffee, were the particularly Honored Guests of the affair. They were: Robert Langford, Co-pilot: Larry Sylvester and John Landermeth, Navigators; Harry "Red" Soderberg and Charles Shusmith, Top Turret Gunners: Charles Brahman, Radioman; George Bogert, Ball Gunner; Gerald Borchert, Waist Gunner and Edward Gallagher, Tail Gunner. (The presence of two Navigators and Top Turret Gunners is due to the fact that more than one crew flew "Shoo Shoo Baby.")

The program prepared by the Dover AFB authorities and the 512th MAW Reserve for the Sept. 10 ceremonies was impressive. Brig. Gen. Carey Deckord was the Master of Ceremonies; Delaware Congressman Tom Carper participated and personally congratulated everyone of the many who received an award for contributing to the restoration project and the East Coast Air Force Band and a Delaware National Guard Band performed. Other contributors to the formalities were: Col. Fred R. Endrikat and CMSGT John Collins, Chairman and Co-Chairman, respectively, of the "Salute to 'Shoo Shoo Baby Committee" and Col. Emmett Venett, Jr., Chairman of the 512th Antique Aircraft Restoration Group, Inc.

Pres. Paul Chryst was presented a 512th MAW Certificate of

Pres. Paul Chryst was presented a 512th MAW Certificate of Appreciation recognizing the contributions of the 91st BGMA. Sec. W.W. Hill received an award for his contributions.

Reliable sources report Pres. Chryst did not sit idly awaiting the 91st BGMA's award. Armed with a "Cam-Corder," he busily took VCR tapes of the entire event - except for the time he had to jog to the stage when called.

Dr. Hospers test flew "Shoo Shoo Baby" again the following day in preparation for her scheduled final flight to the AF Museum at Wright

Patterson AFB, Dayton, OH on Oct. 13, 1988.

Regarding that flight, McDuffee says, "I will sweat out the trip from Dover to Dayton, and once it gets on the Museum side of Wright

Patterson, I will at long last rest very easy."

On Oct. 6th the editor and a photographer went back to Dover for another look at "Shoo Shoo Baby." MSGT McCloskey generously permitted them to climb aboard to take interior photos. Once aboard the editor regretted his choice of light tan, expensive trousers because in some areas, where he had walked before, he had to crawl. (Age.) The perfection of the plane's restoration was confirmed forever when he emerged much later without the slightest smudge upon his trousers' knees. To Dr. Hospers "nearly new" description of the restored "Shoo Shoo Baby," the R/I adds, "She's clean as a whistle!"

Another is the laying of the groundwork for publication of a 91st BG(H) Pictorial History. This project, headed by Action Chairman B/Gen. Earl C. Pate, Jr. (324th), entails identification of places, people and activities depicted on war-time 91st BG(H) photos.

The Jan. 1989 R/I will contain further details on these and other projects along with information on how members can contribute.

Elsewhere in this issue is a published partial list of the 1989-91 officials of the 91st BGMA. At this writing the election results pertaining to a few posts have yet to be determined. It should be noted that both potential occupants of those posts have offered to withdraw their candidacy for the good of the Association. The Chicago Convention was a congenial one.

Harold Lieberman (401st), the 1986-88 BGMA 2nd VP who was elected 1st VP for the 1989-91 term, has been requested to resolve the confusion because of his credentials as an Attorney and a Judge. The complexity of the problem presented him has precluded a decision prior to the Oct. 1988 R/I delayed press-time.

Regarding the above issue Pres. Chryst recently released the

following statement to the R/I:

"It was determined on Saturday, Sept. 3rd, during the Business Meeting, that Col. Louis Montalvo was elected President; Harold Lieberman, 1st Vice President; James Bacon, 2nd Vice President; Hiliary "Bud" Evers, Historian and Rudy Malkin, Editor for the 1989-1991 Term of Office.

Confusion regarding the interpretation of the By-Laws on the subject of absentee voting vs. voting by members present at the scheduled Business Meeting has not yet been resolved legally at press-time for the R/I. The appointments to the Office of Secretary and Treasurer for the next Term of Office will be announced by the Arbitrator (Lieberman) in the January issue of the R/I.

During the Business Meeting Pres. Chryst announced with pride the completion of the project to replace the original 91st BGMA silver bowl which was stolen from the Chapel of the American Military

Cemetery at Madingley, England in 1986.

A beautifully engraved, cast brass bowl, purchased with funds contributed to the 91st BGMA Memorial Account, has been officially approved and will be personally presented to the Superintendent at Madingley Cemetery by Chryst this October. Formal dedication of

the sacred gift is planned for next year.

Historian Hiliary "Bud" Evers provided further documentation of the strides made during the past two years in 91st BGMA projects. He fulfilled the stern admonishment of the By-Laws which says, "The Historian...will make every attempt to list the names of those men who gave their lives while serving with the 91st BG(H) during World War II."

Three preliminary studies compiled by him were available at the Convention for perusual by the membership. They were: 1) A Statistical Study of 91st Aircraft Losses; 2) A Roll of Honor, an alphabetical listing of those Missing in Action, ditched or crashed on a combat mission and 3) A Roll of Honor, listing the Planes and Crews Missing in Action, ditched or crashed while on a combat mission.

Ever's thick documents were available at Duffy's Tavern," the Convention Hospitality Room. In his introduction he acknowledged the help of many members in assembling the data and also the assistance of Historian Paul M. Andrews, "...without whose assistance this study would not have flown.

All members are encouraged to submit to him the names of anyone who died while at Bassingbourn - including ground accidents or any

other cause for inclusion in his data.

Another legacy left by the 1986-88 BGMA term was as much a product of the membership as any official of that time. The Annual Dues were raised from the increasingly inadequate \$5.00 a year to \$10.00 by a unanimous vote.

The new 91st BGMA Directory, produced by Sec. W.W. Hill, must also be numbered among the notable Association achievements of the past two years.

Chicago Convention Chairman Sam Cipolla and his Committeemen Arthur Rowe, Marv Goldberg, Clarence Winchell, Robert Krusen and Armando Sinabaldo provided a "flapless" background for the Convention which was appreciated by all. Congratulatory comments from members after their return home attest to that.



# BY-LAW CHANGES PASSED

THE FOLLOWING BY-LAW AMENDMENTS WERE approved by majority vote of the membership at the Chicago Reunion Business Meeting and the hand count of the Absentee Ballots returned:

#### ARTICLE VII. OFFICERS

Section 1. The following sentence to be added after the first sentence: "The term of office for the principal officers, with the exception of the President Emeritus, shall be for a period of two years beginning the 1st day of January following the elections.

#### ARTICLE VIII. FINANCES

Section 1. The first sentence changed to read:

"The moneys of the Association shall be deposited into two accounts - Operational and Memorial - in the name of the Association in such bank or banks as the President (in conjunction with the Treasurer) shall designate."

Section 2. The second sentence changed to read:

"Operational expenditures will be made for those expenses normally associated with an Association of this type, and shall include but not necessarily be limited to the following purposes.

After paragraph (g) add new paragraph (h) to read: "(h) Funds from the Memorial Account will be used for the purchase and maintenance (including appropiate memorial wreaths) of approved memorials.

Change old paragraph (h) to "(i)."

### ARTICLE VIII. FINANCES

Section 3. The first sentence to read: "The members of the Association shall pay annual dues to the Association of ten dollars (\$10) on a calendar year basis, one dollar (\$1) of which will be deposited into the Memorial Account. Life membership shall remain at \$100, however, ten dollars (\$10) of each new life membership fee will also be deposited into the Memorial Account.

A suggestion to favor a "musical chair" policy whereby the next President would normally have served a lesser officer position before being eligible to become President was not resolved. It was "tabled" for future discussion and/or action.

# 324th SQ's OTTO E. MEIKUS CAMBRIDGE RESIDENT

CONTROL TOWER MUSEUM COMMITTEE MEMBER AND Member of the Friends of the Eigth Air Force Otto E. Meikus traveled the furtherest to attend the recent 91st BGMA Chicago Convention.

One of the volunteers who helps Vince Hemmings maintain the Bassingbourn museum with "cleaning, painting and maintenance just about every Tuesday," Meikus is a former 324th Sq crew-chief who now resides in Cambridge, England. The 91st BGMA plaque presented to him by Pres. Paul Chryst for travelling the furtherest is "immensely appreciated," he said.

Originally from Wisconsin, Meikus was among the original 91sters. One of the planes he and his crew maintained was "Jack the Ripper" which he recalls never aborted while compiling 55 to 60 missions.

Once it was so shot up it took months to repair it.

Because of the many elapsed years Meikus is cautious about remembering somethings emphatically. An example is his recollecting that "Jack the Ripper's" first crew painted mission bombs on the plane's left side - later crews painted the bombs on the right side and added a pin-up picture.

"You better check on that," he cautioned listeners during a long

convention chat.

Accompanying him on his State-side trip which included visiting relatives, was his English bride, Gladys. The two met at the Rex Ballroom in Cambridge during the war and Mrs. Meikus says her initial interest in him was augmented by the fact that she found him "not too bad a dancer." They married in 1945 and she followed him to the States a year later as a War Bride.

Another early "plus" he possessed during their courtship surfaced

in 1985, the Meikus' laughingly recalled. She was interviewed "a bit" for an NBC documentary on English War Brides and during the interview she blurted out another reason she originally liked going out with him. "With Otto I ate steak," she says, "whereas when I went out

with an Englishman it was usually Fish and Chips!

They never saw the documentary but an American friend wrote and

said she saw it, recognized Gladys and heard her say it.

The pleasantness of the Meikus' first 91st BGMA Convention was considerably enhanced by meeting again the former crew-chief of "Pandora's Box" and "Great Speckled Bird," Russel Chamberlain. Chamberlain was the Best Man at the Meikus' wedding in England 43 years ago. His English War Bride died some years ago.

Familial responsibilities dictated the Meikus' English residency. The illness of Mrs. Meikus' mother required them to first return to England in 1953 for a year. Susequent necessary returns constantly required Otto to seek new employment on both sides of the Atlantic. In 1962 they decided to remain in England.

Now retired from his last position as Garage Manager of a Cambridge Volvo firm, Otto, though still an American citizen, has

acquired many English traits.

He doesn't say "garage" the way we do. Offered an American cigarette, he said it would kill him. He prefers his own "so mild" English brand. And, though he and his wife say tea is no longer the dominant English drink, they both departed after one afternoon chat for "a bit of

In addition to the subtle characteristics that now differentiate him from his old friends, he looks like an Englishman. This conclusion was silently arrived upon when the R/I first met and spoke to him at the convention. Higher authorities than the R/I are of the same opinion regarding the 324th's former crew-chief Otto E. Meikus. The producers of a sequel to the film "Winds of War" selected him to portray a Member of Parliament in a bit part of their yet to be released new miniseries, "War and Remembrance." The ABC film is a 30 hour production. The first 18 hours will be aired in November.

If English residency has changed him over the years, the years have also changed England, he says. Visiting 91sters will note the famous fog has been greatly diminished by modern heating systems; the center of old Cambridge is now a shopping center; pubs now serve food; Kohlsberg beer is popular; London seems to becoming "cluttered" (he remembers it "clean") and living is more expensive

than in the States.

"The good news," he says, "is Bassingbourn basically looks the same.



A KIND OF BOOK REVIEW

# BASSINGBOURN'S "BILLY" IN BIRDSONG'S BOOK



Then-Capt. George P. Birdsong (323rd) awards his plane a DFC after it completed 25 missions during the difficult, early operations of the 91st BG(H). "Delta Rebel No. 2" (25077-ORT) was among the four 91st planes later lost during the Gelsen Kirchen raid on Aug. 12, 1943 while being flown by 1Lt. Thompson. This is one of the many historical photos included in Birdsong's recently released book.

MEMBER CHARLES "CHUCK" GALIAN'S HUMOROUS article in the July 1988 R/I regarding the belligerent "Billy" charging about the 91st's Bassingbourn Base closed with questions.

Two books on 91st BG(H) history answer all but, "What happened

The first book, unpublished, by Lt. Charles Carlton Brechler, the 91st's war-time Public Relations Officer, first shed more light on the "Billy" goat affair. (91st BGMA Historian Hillary "Bud" Evers had sent a xeroxed copy of Brechler's, "Wray's Ragged Irregulars" manuscript earlier to the editor for persual.)

In Brechler's excellent account of early 91st operations mention is made of Base mascots. "Red Line" was not alone. The existence of a goat on the Base is confirmed by Brechler who closed his mascot paragraph with the phrase "...and one squadron kept a goat named Amitol.

Soon after discovering that bit of evidence that a goat was a regular resident at Bassingbourn the editor was ensnared by the other

absorbing book.

The "other" is the recently released book, "Stormy Weather, a B-17," by Col. George P. Birdsong (he prefers to be called "George"), which coincidentally appeared on the market about a month after Galian's article in the R/I. It answers Galian's other questions. They were: "Who owned him? How did he get on the base?"

It's a great book and, once begun, is difficult to set aside.

His book is a trilogy - packed with action and humor. His account of "The Royal Air Force Affair" and surviving Col. Stanley T. Wray's wrath vies with the best of the combat text which is superb. (Birdsong's bombadier's contribution to the "affair" prompted the infuriated Wray to ask Birdsong if his bombardier was "... some kind of sadistic Anarchist?!!'

The account of Birdsong's disruption of the departure ceremonies for the War Bond Tour bound "Memphis Belle" is another gem.

After reading so many delightful antecdotes it wasn't surprising to learn, near the book's end, that Birdsong and his "errant" bombardier, Robert G. Abb, were the original owners of "Amotol," the goat that probably assailed Galian.

Writing about his last days at Bassingbourn, Birdsong says, "...That goat had grown from a small kid to almost full size, had a good set of

horns, and liked to butt anything ..

'Amotol loved to eat cigarettes, but strangely, would not touch a Camel. Luckies, Old Golds, Chesterfields and Ralieghs he chomped, but he would turn up his nose at the smell of a Camel. Strange. Didn't know whether that was good or bad

"Guess we'll just leave old Amotol with the new lads..."

Though Brechler's unpublished book identifies the Bassingbourn goat as "Amitol" while Birdsong calls him "Amotol," it is certain Galian's assailant has been identified. He was mascot of the 323rd Sq.

Now the R/I awaits the answer to Galian's last question, "What

happened to him?" Anyone out there know?

Birdsong and his wife, Eileen, report that more than half of the first edition of "Stormy Weather, a B-17" has been sold with little or no advertisement. (All the books they brought to Chicago were gobbled up by 91st history hungry Conventionaires.)

Copies of his generously illustrated (including excellent diagrams clarifying the Combat Box Formation for all) hard cover book may be obtained from the Hambleden Publishing Co., P.O. Box 2681, Dublin, CA. 94568 which is presently the exclusive sales source. The price is \$17.95 plus \$2.00 for postage and handling. Californians ordering a book must add \$1.26 for sales tax.

It must be added that the editor is studiously avoiding the copy of "The Memphis Belle, Home at Last" book by Menno Duerksen sent him by Frank Donofrio of the Memphis Belle Memorial Assn. Having read into it a bit there is no doubt that it to is such an attention grabber that 91st BGMAers would find the next R/I irksomely delayed if the editor now succumbed to its lure.

These books are two great chapters of 91st BG(H) history. Any 91ster wishing to treat himself or anyone wishing to treat a 91ster this coming Christmas should consider one or both as a gift which will be

truly treasured.

(Birdsong invited comments from the R/I editor regarding his book. The only criticism worth noting is "George" failed to include at least one paraoraph on how many "Rigid Digit Medals" the frustrated 91st BG(H) CO,Col. Wray probably thrust, with mixed emotions, upon the Excellent Problem-Pilot of the 323rd's "Delta Rebel II?")


Powers, while kicking the bombs, was in good hands. Mazaika



# PHOTO BLOW-UP REVEALS WAR-TIME "SHOO SHOO BABY"


Originally, the article below bore the head-line, "WWII 401st FORMATION PHOTOS SLATED FOR SCOTTISH MUSEUM." Though no illustration was intended to accompany it, the 401st formation photo that had been used in the Jan. 1988 R/I was scrutinized with a magnifying glass

The scrutiny produced the suspicion that one of the pictured planes was "Shoo Shoo Baby" doing her thing An enlargement confirmed

the suspicion!

The original bare metal finish of "Shoo Shoo Baby" (232078, E-LL) is apparent in the photo. Because 16 years of neglect outdoors caused deterioration of the alcalade skin coating, the 512th MAW of Dover, DE AFB, included painting her in the proper colors for Forts before the bare metal finish came into use

This photo was taken by then-Lt Allan N. Morey while a Co-Pilot with the 401st Sq. More "Shoo Shoo Baby" restoration news is included in this issue.



THE JAN. 1988 R/I FEATURED AN ARTICLE ON FORMER Maj. John D. Davis' 401st crew which was accompanied by a never before published war-time photo of a 401st formation. The photo was taken by former 1Lt. Allan Morey while he was co-pilot on the crew.

Some years ago Morey entrusted his re-discovered negatives to the present R/I editor "for possible use." Later, Photographer John Hohman, AM generously made a few enlargements from the negatives. A copy of each of the excellent enlargements was sent to Morey.

John Fleming, of Scotland, is deeply involved in obtaining historical exhibits for the three "General Eisenhower Rooms," in the Culzean Maybole Ayrshire Castle, donated by the people of the "West" of Scotland.
